### **Part- I Technical bid**

### **Part- II Financial bid**

Sealed financial bid shall contain duly filed up Table indicating supply price inclusive of all taxes and duties and software installation.

- (ii) The bids shall be submitted in form of a computer printout signed at the bottom by the bidder/authorized representative of the bidder.
